Fee for Insufficient Funds (per item)¹ <ul style="list-style-type: none"> Return Check Overdraft / Non-Sufficient / OD-NSF NSF Attempt to Post Fee² <p>¹ Charged once the account balance reaches negative \$100. If we choose to pay an overdraft or overdrafts that cause your account to be overdrawn less than \$100, you will not be charged an overdraft fee. For all additional items that cause your account to be overdrawn \$100 or more, you will be charged the fee for each item. For example, if a check for \$75 clears your account that only has \$45 in it, the resulting balance in the account would be -\$30 and you would not be charged. If a subsequent item for \$100 clears the account causing the balance to drop to -\$130, you would be charged an overdraft fee for that item.
